We hereby report change of Representative Executive Officer resolved at meeting of the board of directors held on February 20th, 2009 has been fixed as follows

1. Reason for Change

Hideo Ishii, Director, President, Representative Executive Officer and Co-CEO of Asahi Tec Corporation, was appointed as Representative Executive Officer in June, 2007, and has been primarily focusing on improvement of business performance which also include successful bond tender of Metaldyne, our subsidiary in US. Facing with steep drop in automotive market worsening day by day since latter part of fiscal year 2008, Ishii has also been aggressively led restructuring process along with organizational changes to rationalize overall operation. However, with the fiscal year end coming in March 31, he resigns for personal reasons.

In light of recent worsened economy and business environment, Shoichiro Irimajiri, Director and Co-Chairman of the Board, will succeed Ishii's position as an additional post, and at the same time, Hirohisa Yamada, Executive Officer, Financial and Accounting, will assume Representative Senior Managing Executive Officer and Chief Operating Officer(COO), and Masataka Matsumura, Senior Managing Executive Officer and Chief Financial Officer(CFO), will also take Representative Executive Officer post in addition to current position.
